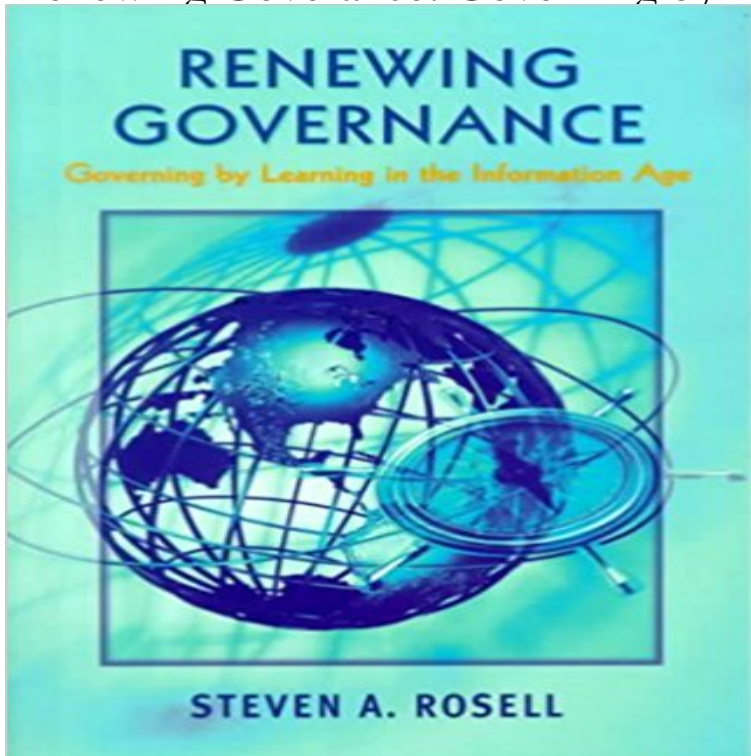


Renewing Governance: Governing by Learning in the Information Age
