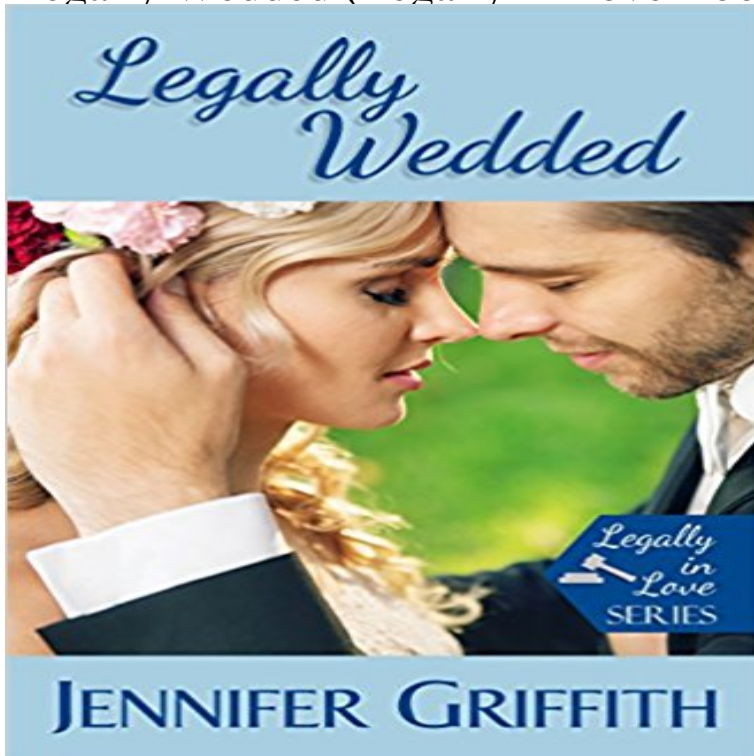


Legally Wedded (Legally in Love Book 3)
