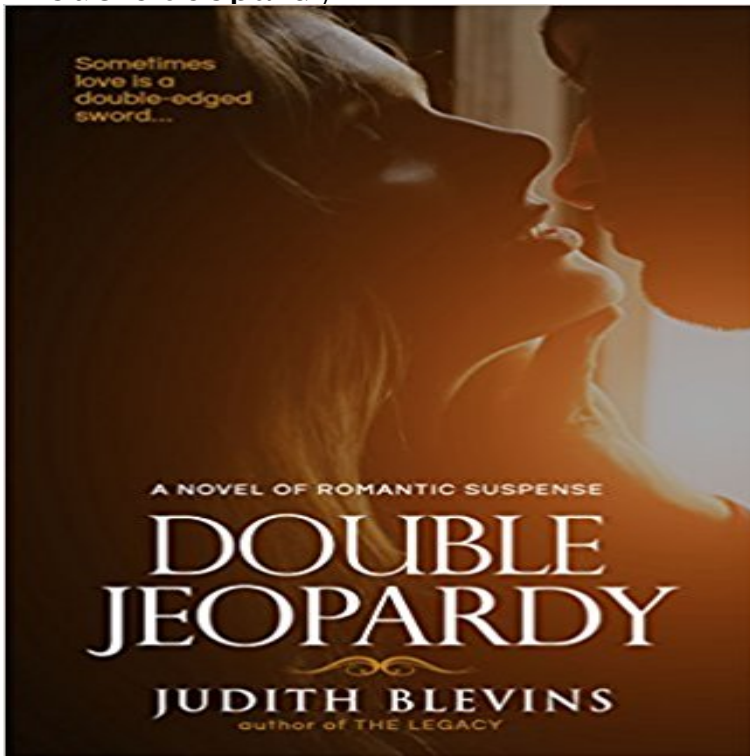


## Double Jeopardy
